## **OBJECTS AND PURPOSES OF THE ASSOCIATION**

The objects of the association are:

## **ELIGIBILITY FOR MEMBERSHIP**

The following eligibility criterion is necessary for membership of the association:

- a. The member must be a registered business, company (a company must specify its duly appointed representative) or government agency working in and servicing the wider Alexandrina area and
- b. Must support the objects and purposes of the association and
- c. Agrees to be bound by the rules of the association and
- d. Applies for membership of the association and
- e. The application for membership shall be made in writing, signed by the applicant and the proposer and seconder.
- f. Upon the acceptance of the application by the committee and upon
- g. Payment in full of the annual subscription then the applicant shall become a member of the association.

## **SUBSCRIPTION FEES**

- a) The subscription fees for membership shall determined by a majority of members present at a general meeting.
- b) The subscription fees shall be payable annually on 1 July or at such other time as the committee shall determine.
- c) Any member whose subscription is outstanding for more than three months after the due date for payment shall cease to be a member of the association, provided always that the committee may reinstate such a membership on such terms as it thinks fit.
